The next step is to send the products to healthcare organisations where the products are stocked in the inventory to ensure easy access to service providers and patients.

The healthcare supply chain also includes the intervention of various regulatory bodies like the FDA (Federal Drug Administration), etc., and public and private medical insurance companies. The involvement of multiple stakeholders with their own goals that are not aligned with those of the others leads to cost variance and off-contract spending. Besides there are several hidden cost components like the time spent in looking

for supplies or waiting for delivery of products. Another factor that has disrupted the healthcare supply chain is the deep-rooted impact of the COVID-19 pandemic. The pandemic has put a strain on the healthcare supply chain that organisations are still struggling to recover from. Post-pandemic healthcare organisations are coping with active supply shortages coupled with the high costs of everyday

medical products and equipment. These cost components in the healthcare supply chain cannot be ignored because data indicates that medical supplies constitute one-fifth of hospital expenses, which is a significant factor.
